The Netsys' NL-230F is a 2 Giga LAN over LRE Extender with DIP switch that's built in Long Reach Ethernet (LRE) UTP / Coaxial /Fiber Optic for data transmission via 10/100/1000BASE-T Ethernet cable (UTP) over LRE UTP/ Coaxial &1.25G/2.5G SFP Fiber modules. With DIP switch on rear side of NL-230F, it's easy for customer to configure SFP Mode for 100M/1.25G/2.5G and LRE of single pair mode as well as 10/100/1000 Base-T Ethernet ports support selection by DIP switch, etc. NL-230F support auto-negotiation & auto-MDIX to properly set up the most stable & fastest connection between NL-230F and support multimedia interface converter such as copper wire / coaxial cable / fiber optic.

NL-230F support 2 x 10/100/1000 Base-T LAN over LRE 10 / 100Mbps Copper / Coaxial and 1.25G/2.5G fiber optic network, and small form-factor pluggable transceiver is required. NL-230F also supports 9K bytes jumbo frames pass-through which is perfect to utilize in AI, IoT, video streaming application, VOIP, etc.

Chapter 2. Hardware Description

This section describes the important parts of the converter. It features the front panel and rear panel.

1. Front Panel: The front panel provides F-Connector / SFP Slot, Ethernet Connector and LED indicators of the converter.

Front panel indicator: There are 8 LED indicators on Converter, the following Table shows the description.

2.2 Application Diagram

Even though Fiber optic is a proper developed technology, it still can't reach some places due to cost & physical limit. NL-230F is a 2 Giga LAN over LRE extender that supports data transmission between Fiber optic and Coax. on the end point, which give you an alternative way to extend the bandwidth to Maximum 2.5Gbps without further wiring renovation.




Figure 2.2 Application Diagram

Appendix A: Cable Requirements

Ethernet Cable

A CAT 5~7 UTP (unshielded twisted pair) cable is typically used to connect the Ethernet device to the Modem. A: 10/100TX cable often consists of four pairs of wires, two of which are used for transmission. The connector at the end of the 10/100TX cable is referred to as a RJ-45 connector and it consists of eight pins. The Ethernet standard uses pins 1, 2, 3 and 6 for data transmission purposes. (Table A-1 10/100TX)

B: 1000TX cable often consists of four pairs of wires, all of which are used for transmission. The connector at the end of the 1000TX cable is referred to as a RJ-45 connector and it consists of eight pins. The Ethernet standard uses pins 1, 2, 3, 4, 5 and 6 for data transmission purposes. (Table A-1 1000TX)




Figure A-1 Standard RJ-45 repectacle/connector




Figure A-2 Pin Assignments and Wiring for an RJ-45 Straight-Through Cable



Appendix C: DIN-Rail mount installation

This appendix describes how to install DIN-Rail Type-B(optional) to the bridged. The accessory is optional.

- Please refer to install the DIN-RAIL as following step:
- 1. Install the DIN-Rail mounting plate to the NL-230F. (Figure C-1)
- 2. Please use the suitable DIN-Rail to install, please refer to the dimensions of DIN-Rail (Figure C-2)
- 3. Insert the top of the DIN-Rail into the top slots on the DIN-Rail mounting plate and the DIN-Rail mounting plate will snap into place. (Figure C-3)



Appendix D: Troubleshooting

Diagnosing Giga Media Converter Indicators

NL230F can be easily monitored through its comprehensive panel indicators. These indicators assist in identifying problems may encounter. This section describes common problems you may encounter and possible solutions:

System Diagnostics

Power and Cooling Problems

If the POWER indicator does not turn on when the power cord is plugged in, you may have a problem with the power outlet, power cord, or internal power supply. However, if the unit power is off after running for a while, check for loose power connections, power losses or surges at the power outlet. If you still cannot isolate the problem, then the internal power supply may be defective. In this case, please contact your local dealer.

Installation

Verify that all system components have been properly installed. If one or more components appear to be malfunctioning (e.g. the power cord or network cabling), test them in an alternate environment where you are sure that all the other components are functioning properly.

Transmission Mode

The default of transmission mode for RJ-45 ports is 10/100/1000 Mbps LAN port, for SFP port is 1.25Gbps/2.5Gbps SFP mode, for LRE UTP port is 10Mbps / 100Mbps or Coax port is 100Mbps, Therefore, if the Link signal is disrupted (e.g. by unplugging the network cable and plugging it back in again, or by resetting the power), the port will try to re-establish connection with the attached device via auto-negotiation

Physical Configuration

If problems occur after altering the network configuration, restore the original connections, and try to track the problem down by implementing the new changes, one step at a time. Ensure that cable distances and other physical aspects of the installation do not exceed recommendations.

System Integrity

As a last resort verify the switch integrity with a power-on reset. Turn the power to the switch off and then on several times. If the problem still persists and you have completed all the preceding diagnoses, then contact your dealer.
